Nowadays, when Russia is a wealthy country, the majority of its population lives in poverty and about 20 million Russians are unable to climb out of abject poverty. Our party is firmly committed to the fight for adoption of the laws and creation of the conditions that can lead to vanishing of these shameful phenomena from the life of our people. It would be impossible to achieve this aim without the specific laws and acts that first of all, must be fair for the people of labor and for the needy.

That is the reason why A JUST RUSSIA goes into the election with a definite five-year program of legislative initiatives having a distinct social orientation which allows taking of a real step toward the fairness in our life year after year.

Steps toward fairness

- Adoption of the Law of Employer Liability for Labor Code Violations: 100 percent compensation for material damage; 100 percent compensation for moral damage; 100 percent fine in favor of State. The use of irregular migrant labor shall be liable for a big fine and the costs of illegal immigrants deportation shall be covered.
- 2. Rise of pension supplement from 1 to 5 percent for each year worked after the pension qualification age. Increased pension payment from the age of 70.
- 3. Provision of 50 percent (and more) of the children registered in queues for kindergarten with vacancies. Mothers having children aged 3 to 5 who are not enrolled at kindergartens must receive a budget child care benefit.
- 4. Introduction of a progressive tax scale and attainment of the election of governors.
- 5. The landholders having up to 8 decares of land shall be exempt from land taxation.

- 6. Growth of natural monopolies' tariffs and of the utility rates shall not exceed an official inflation rate.
- 7. The fuel and lubricant prices for agricultural producers shall be preserved at the autumn 2011 level, and their growth shall not exceed the inflation rate.
- 8. Adoption of the direct-applicable anti-corruption law which equals bribery to treason. Confiscation of property shall be extended as punishment for corrupt officials and their families. The bodies of power or definite officials whose illegal actions or failure to act resulted in damage shall bear material responsibility.
 Spendings of the law enforcement officials and their families shall be taken under control.
- 9. Setting up of a Public Council for observation of the public moral principles and standards in the Media, especially on TV.
- 10. Introduction of a nonrecurring compensation tax on the property privatized at a lower price. Introduction of a 20 percent tax on capital transfer from Russia.
- 11. Creation of the building and loan savings banks providing people with an opportunity to save 25–30 percent of the housing cost, and the rest 70–75 percent of the required sum may be given to borrowers as a long-term low-interest loan with a 5 percent interest.
- 12. Toughening of responsibility for the crimes relating to drug trafficking and illegal circulation of alcohol products.
- Establishment of State monopoly on alcohol production and circulation, introduction of tax on imputed income in the production of liqueurs and spirits.
- 14. Enacting at the federal level of not more than 10 percent of the aggregated family income as the maximum permitted proportion of the citizens' housing expenses and their payment of utility services.
- 15. Impose a graduated income tax on large incomes.

- The costs of employment programs shall be established at the rate of 1 percent of GDP (Gross Domestic Product). Implementation of large investment projects in each region of Russia, and creation of not less than 10,000 jobs per 1 mln. people in a region.
- 2. Abolition of the pension provision benefits for officials.
- 3. A guaranteed employment, establishment of quotas (the first job) for university graduates and the leavers of secondary specialized schools.
- 4. Introduction of the preferential credits for definite purposes at the CB (Central Bank) rate + 3% for the production modernization programs and small and medium-sized businesses.
- 5. Provision of granting the land plots, with the publicly funded setting of boundaries and completion of documents.

- 6. Toughening of responsibility for the crimes committed on the grounds of interethnic and religious hostility.
- 7. Spending control over the deputies and other elective officials as well as the leaders of the federal and regional bodies of power, their substitutes and family members.
- 8. Introduction of the quota system for the foreign TV, video and audio products, establishment of the legal, tax and public control over the products of mass culture.
- Wealth tax introduction: tax on the real estate with the cost over 20 mln rubles, means of transportation - over 2 mln rubles and jewelry – over 300,000 rubles.
- 10. Introduction of a three-stage resource rent extraction by means of
 - 1) the tax on extraction of commercial minerals
 - 2) the optimized and flexible export duty
 - 3) monthly licensed payments for natural deposits
- 11. Decrease by 50 percent of the tax burden on modernization of production, innovation, small and medium business.
- 12. Issue of non-interest loans to young families to buy housing. Writing down of 25 percent of the loan (public funding) after the birth of the second child.

The better lives the family — The better lives the country!

- Adoption of the law on annual (up to 2020) public sector wage and salary indexation (healthcare workers, education, academic and research workers, science and culture workers) in the amount of «inflation+10%». Establishment of the status of civil servants for workers of the budgetary sector and their provision with the corresponding social guarantees.
- 2. Adoption of the law on indexation of pensions in line with the rise of average earnings in the country.
- 3. Introduction of supplementary pensions for a responsible parenthood: bringing up of three children (or more) without criminal convictions.
- Mass construction of social housing for a long-term renting at discount prices by the low-income families that are in desperate need of housing improvement.

- 5. Tax breaks, credit relaxation, state investment and subsidies for the investment projects for production modernization, storage, transportation and processing of agricultural products.
- 6. Spending control over all federal government employees and their family members.
- 7. Establishment of liability of the Internet providers and Media owners for the products violating the public moral principles: pornography, propaganda of drugs, xenophobia and extremism.
- 8. Introduction of the "family salary" not lower than the social consumption standard for one of the spouses involved in bringing up of three (or more) children.
- 9. Strengthening of criminal responsibility for the crimes committed against life and health of citizens, and establishment of material compensation up to 2 mln. rubles at the criminal's expense (according to the damage severity).

A Uniform Pension Act - for each citizen!
Pension is not CHARITY!
Pensions shall guarantee a dignified life!

- 1. The established lowest level of earnings shall proceed from the value of the social consumption standard including not only the expenditures on of food and articles of daily necessities but also housing maintenance costs, education expenditure, public cultural expenditures, medical care expenditures and the ones on rest and leisure. Fixing of the minimal level of earnings per hour (90 rubles) with three types of multiplying ratios: regional, industry and qualification.
- 2. The established minimal pension shall not be lower than the social consumption standard.
- 3. Mass construction of the residential facilities of noncommercial use for a long-term renting at the prices completely covering the costs of construction, operation and maintenance.

- Adoption of the program of development of the socially owned enterprises, granting of credits on easy terms and tax deductions at employee buyout.
- 5. The school leavers from rural areas shall be provided with quotas at higher educational institutions for the professions that are needed in their areas. Provision of agricultural specialists with 50 percent subsidies for construction and buying of houses. Restoration of the utility service payment relief for budget workers in rural areas.
- 6. Introduction of spending control over the regional authorities and officials and their families.
- 7. Restoration of a network of children's and youth sports and arts schools and clubs accessible to all citizens. Provision of support for young talents, in particular, with the help of the State Grants Programs.

Payment for Housing and Public Utilities shall not result in impoverishment of Russian families! "NO" to the swindlers from managing companies!

- 1. Establishment of unemployment compensation not lower than the social consumption standard.
- 2. Rise of the average retirement income to 60 percent of the former wage or salary.
- 3. Switching to ruble payment for the export products of Russian produce.
- 4. Support of peasant income with the help of state purchases. Creation of an electronic system of agricultural products distribution to provide a remote sale with further delivery to the definite customer.

- 5. Strengthening of criminal responsibility for the crimes against property of citizens. Introduction of liability to pay full material losses by a criminal.
- Introduction of spending control of the municipal officials and their families.
- 7. Provision of the Internet access for each citizen of Russia.

Rural areas are indispensable parts of Great Russia! It is much cheaper to provide support to your people than feed strangers!
